REMR COMMUNITY RESILIENCE FUND – TERMS AND CONDITIONS

Successful projects must be of clearly defined benefit to the communities of Kingswood, Wickwar, Hillesley and environs.

Retrospective applications (ie where expenditure has already been incurred) will be ineligible for funding from this source.

Receipt of any funding received from the REMR Community Resilience Fund must be acknowledged by grant recipients if they mention their project publicly. The recipient will do nothing which may adversely affect the reputation of REMR or generate adverse publicity for REMR.

The Society may detail approved projects and funding recipients within its own publicity and in related activities concerning community resilience.

Prior to expenditure, funding recipients will be required to provide evidence that the use of the funding granted, will be in accordance with the application approved for funding. Recipients will maintain separate, accurate and up to date financial records as to how the grant has been spent, including records of receipt and expenditure.

Funding recipients must provide a suitable photo of the project activity which the funding has helped to facilitate within 6 months of receipt of funding and provide such information and assistance to REMR as required to ensure a positive and co-operative relationship.

If for any reason an approved project does not go ahead within 6 months of funding being granted to the recipient, the funding must be returned to the REMR Community Resilience Fund for reallocation to future applicants, unless an extension of time has been agreed and put in writing by the Board of Resilient Energy Mounteneys Renewables.
